Your income may need to be reassessed to ensure your eligibility for this property. 4. Your application will be processed on the understanding that it is subject to a visual inspection and accepted its current conditions prior to lease sign up. 5. <u>Please ensure all details are provided at time of application, we will not be able to follow up for required information. Application will not be processed if all documentation is not provided.</u> 6. We will contact you if your application is successful. When properties become available approved applications will be given to owners for final allocation to a property. 7. Prior to moving into a property a total of 2 weeks rent in advance (which will included your one week's deposit) plus 4 weeks bond MUST be paid by money order, direct deposit or bank cheque. 8.
